- Substance Use and Recovery:
 - Recovery is a process of change through which individuals improve their health and wellness, live selfdirected lives and strive to reach their full potential Health, home, purpose, and community are the four major dimensions that support a life in recovery. This provides students in recovery from addiction a safe, sober environment that assists and support. There is currently a total of 38,000 students on UCSD campus and about 12,008 students who meet the criteria for substance abuse.

 - Creating an LLC partnership between the colleges, HDH and student health and well being to create a living learning community.
 - Substance free activities will be planned to build community and service-learning activities.
