Waitlist Process

o Grill Maintenance

- Issue brought up was the grills are frequently broken. When custodial & maintenance clean them improperly and placing tinfoil to make the cleaning process easier.
 - Custodial will no longer do foil in the grill & will order new brushes.
 - New laminated signs about fixit and suggestion box in the communities.
